

# **CarShield Zamboni Cooler Sweepstakes**

## **Official Rules**

### **1. Eligibility**

The Zamboni Cooler Sweepstakes is open only to legal residents of Missouri and Illinois who are at least 18 years old at the time of entry. No purchase necessary. Purchase or acceptance of a product offer will not improve your chances of winning. Completed declaration and release must be returned within 48 hours (including Saturdays, Sundays and Holidays).
